## ONE-YEAR LIMITED WARRANTY FOR LAMINATE PRODUCTS

Countertop Connections, Inc. hereby warrants the workmanship, labor and materials for laminated products provided in accordance with the approved contract documents, drawings, and specifications for a period of **(1) year from the date of delivery and/or installation.**

When properly used and maintained, laminate countertops can provide many years of dependability. The limited warranty applies to defects related to fabrication and installation workmanship performed by Countertop Connections, Inc. This warranty is non-transferable and only extends to the original purchaser.

This warranty generally covers:

- Fabrication defects leading to delamination, bubbles, or adhesive failures
- Improperly bonded seams that have failed due to hardware or adhesive failures
- Installation related issues that may cause countertop movement or instability
- Replacement of defective materials that are covered under manufacturer warranties

This warranty does not cover:

- Improper care, misuse, abuse or accidents
- Chips, scratches, dents, or cracks caused by impact, stress, pressure, structural movement, improper support, or thermal shock
- Damage caused by customer installed sinks, plumbing, appliances or other trade work
- Damage due to water, excessive moisture, standing water, plumbing leaks, climate or humidity issues
- Heat exposure from hot pans, crock pots, air fryers, coffee makers, or other heat sources
- Chemical damage from harsh or abrasive cleaners
- Normal wear and tear, fading, cosmetic aging or damage from extended use

Countertop Connections, Inc. is not liable for any other expenses incurred outside of the approved contract, drawings, and specifications including, but not limited to: demo work, plumbing, electrical, tile, drywall, paint, and appliance handling and/or installation. Other trade work may be required for warranty claims, and those trades will fall outside the scope of warranty coverage by Countertop Connections, Inc. if they were outside of the original scope of work in the approved contract.

Products must be inspected at the time of delivery, or within **(1) week of delivery and/or installation**, for any claims that damages or defects were present at the time of delivery and/or installation. Countertop Connections, Inc. reserves the right to repair or replace defective materials in a reasonable and timely manner. Estimated delivery dates are not guaranteed, and this warranty does not cover any additional expenses incurred including, but not limited to loss of profits and revenue, due to a delay in material availability.

No employee, dealer, agent, installer or representative of Countertop Connections, Inc. is authorized to alter or amend any aspect of this warranty.

Recommended care guidelines to help maximize the life of your countertops:

- Use cutting boards instead of cutting directly on the surface
- Always use hot pads and trivets under any heated items
- Avoid allowing water to sit around sinks, seams, or backsplashes. Keep all seams as dry as possible.
- Do not place heat-generating items directly over seams
- Avoid using excessive force or weight on the countertop
- Clean surfaces with mild soap and non-abrasive cleaners
- Follow the manufacturer's guidelines for care and maintenance
